Relevant literature relating to the Company such as Annual Reports, Code of Conduct, etc. are provided to the Independent Directors on their appointment;
- At various Board meetings during the year, presentation is made to the Board on the operational & financial performance of the Company, market share, compliances, major litigation, regulatory scenario etc., which keeps the Directors updated on the operations and the key development impacting the Company.
- Site/factory visits will also be organized for the Directors, as and when feasible.

Regular updates on relevant statutory and regulatory changes are regularly circulated to the Directors
